The Safe School Plan was reviewed and approved by the faculty on December 1, 2011

A comprehensive Emergency plan and School Safety plan have been designed for the safety and well being of students and staff. The plans promote emergency and earthquake preparedness drills, staff in-service for crisis response, systematic campus supervision and safety. Heideman implements a School Wide Positive Behavior Intervention Support (PBIS) program that promotes safety as part of student behavior expectations. In addition, Heideman is a closed campus during school hours. All visitors must sign in at the front office and wear a visitor badge while on campus. Heideman holds emergency drills on a monthly basis. Heideman also participates in district wide emergency drills during the school year. The School Safety Committee evaluates the plans annually and amends them as needed. The School Safety Plan is also reviewed by School Site Council. The principal, custodian, front office, and noon supervisors all utilize walkie talkies (radios) as part of our safety plan. In 2009-2010, the radios were upgraded, Districtwide. The new/upgraded radios give us the capability of communicating with the district office, other schools, and law enforcement in the event of a major emergency. Our Safety Plan is also reviewed with the CDC and Think Together programs on site.

Year and month in which data were collected: December 2011

Robert P. Heideman School was built in 1969 with major renovations made in 1991. New classrooms and offices were constructed in 1990/91 to replace some of the portables. A well-equipped playground, lunch cover and additional parking lots were added to the school site. The Heideman Kindergarten Readiness Academy held its first class in September 2007. The Kindergarten Readiness Academy offers one morning class and one afternoon class. Heideman shares the site with the Orange County Department of Education Special Schools, with three classrooms designated to OCDE. Heideman also shares the site with the Heideman Child Development Center (CDC). The CDC program offers a Preschool class as well as before school and after school child care. Heideman acquired three classrooms from OCDE in 2009-2010. These three classrooms will increase our capacity by approximately 100 students. District maintenance and grounds personnel provide for the repair of facilities and care of the school grounds. The exterior of the school was painted in summer of 2010.

IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the number of days provided for professional development and continuous professional growth in the most recent three year period. Questions that may be answered include:

- What are the primary/major areas of focus for staff development and specifically how were they selected? For example, were student achievement data used to determine the need for professional development in reading instruction?
- What are the methods by which professional development is delivered (e.g., after school workshops, conference attendance, individual mentoring, etc.)?
- How are teachers supported during implementation (e.g., through in-class coaching, teacher-principal meetings, student performance data reporting, etc.)?

All Tustin Unified School District teachers are given the opportunity to attend participate in a variety of District in-services as well as professional development workshops and conferences to enhance their knowledge and instructional skills. Curriculum Consults include representation from all district schools and meet to evaluate and recommend to the Board of Education all curricular changes, new courses, and instructional materials. The Beginning Teacher Support and Assessment (BTSA) program, district workshops, Effective Schools Conference, and professional conferences are opportunities for professional development. The district continues to train teachers in strategies to deliver a differentiated curriculum with depth and complexity. Teachers utilize student assessment results to target instruction to better meet the assessed needs of students. In addition, Heideman teachers participate above and beyond the minimum professional development. Heideman teachers are provided with opportunities to participate in additional professional development, including, but not limited to: Systematic ELD, SDAIE, GLAD, direct instruction, RtI, PLC, SMARTBoard Training, Document Camera Training, SMARTSlate, Training, GATE, BTSA, DIBELS, LETRS, and UCI Math. Additionally, Heideman is in the process of purchasing iPod carts for use in the classroom and hands-on technology. Heideman is on a Banking Minutes schedule which provides teachers with opportunities to meet on a regular basis. Teachers use this time to collaborate with their grade level teams to analyze student assessment data to target instruction to better meet the individual needs of each student. The RtI (Response to Instruction) intervention was fully implemented in grades K-5 in the 2008-2009 school year. The RtI intervention takes place five days per week. Heideman worked with the district RtI TOSA and will continue the collaboration in 2011-2012. Additionally, further professional development is in the planning stages for writing and reading instruction.
