III. School Climate

School Safety Plan (School Year 2010-11)

The Loma Vista staff and parents have developed a comprehensive school safety plan for the safety and well-being of all students and staff throughout our regular school year and in the event of an emergency. We maintain disaster supplies, first aid backpacks, and posted evacuation and emergency crisis plans in every classroom. The safety plan mandates emergency and earthquake preparedness drills and staff in-services in crisis response and systematic campus supervision. Our students understand the importance of safety drills and are commended for their adherence to our procedures during emergency drills. The Safety Plan was reviewed, updated, and approved on December 13, 2011. The Safety Plan was discussed with faculty on December 14, 2011. The key elements of the Safety Plan are outlined in 10 chapters: (1) Child Abuse Reporting Procedures, (2) Disaster Procedures, Routine and Emergency (SEMS), (3) Suspension, Expulsion, or Mandatory Expulsion Recommendations, (4) Procedures to notify teachers of dangerous pupils, (5) Sexual Harassment Policy, (6) The provisions of any school-wide dress code, (7) Procedures for safe ingress and egress, (8) Safe and Orderly Environment, (9) Rules and Procedures on School Discipline/Dress Code, and (10) School Safety Goals and Objectives.

The Loma Vista campus is located on a 10-acre property and was opened in 1957 and has continuously served students since. As the student population increased, portable classrooms were added to the property. The facility is clean and well-maintained through the service of two site custodians and the district maintenance staff. The measure G city bond modernized the facility in 2004 and meets the state requirements for handicapped. The PTO and School Site Council have utilized funds to create a computer lab and relocate our library to a larger classroom to house more books for students. The facility inspection upon which this report was generated was completed on December 5, 2011.

IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

- What are the methods by which professional development is delivered (e.g., after school workshops, conference attendance, individual mentoring, etc.)?
- How are teachers supported during implementation (e.g., through in-class coaching, teacher-principal meetings, student performance data reporting, etc.)?

In regards to our educational programs and instruction, our dedicated teachers engage in collaborative planning grade level meetings three Wednesdays each month. Data collaboration meetings have been embedded within the school day, facilitating opportunities for teachers to meet twice each month for 40 minutes to discuss student learning and best instructional practices. The principal provides bi-monthly Staff Professional Development meetings that focus on the processes of Response to Instruction (RtI), differentiating instruction, English language development, data interpretation and analysis and best first instruction. Along with the full implementation of ELD, we continue with our fourth year of refining the systems of RtI in order to meet the needs of all learners in the area of language arts. We continue to work on implementing the systems and processes of a Professional Learning Community (PLC) school culture, as well. This year the entire Lead Learning Team (LLT), which consists of one teacher from each grade level, the principal, the resource teacher and our Cotsen mentor are LLT members will attend a two day training with Rick and Becky DuFour in January to build capacity. The LLT meets once a month to discuss timelines, data, systems and collegial support strategies - with a driving purpose of impacting student learning. Finally, Loma Vista is participating with the Costen, The Art of Teaching program this year. We have one mentor teacher facilitating the processes for six Cotsen fellows.
