Earthquake, fire, and emergency drills are scheduled so that our appropriate and timely response in a time of crisis is ensured. Emergency procedures, including evacuation, attendance, search and rescue, and lock down procedures are discussed with the Leadership Team and in staff meetings. Gates on the campus are kept locked. Visitors are required to wear a visitor badge and sign in upon entering the campus. School safety is top priority.

Tustin Ranch Elementary School was built in 1995. The school site accommodates over 690 students. The TUSD maintenance and grounds personnel maintain our facility and grounds with care. Our school library currently has over 10,000 books and is the "hub" for the Accelerated Reader Program. This A Sports Park, which provides additional areas for Physical Education, surrounds the playground and is utilized for other school related events. Our award winning facility is a model for technology with over 135 computers in classrooms, hallways, and in the computer lab. We are also very proud to have Smart Boards, and document cameras in every classroom throughout the school. In addition, through PTA fundraising, we've been able to reconfigure our computer lab with a new design as well as new computers and a Smart Board. We are proud of our state of the art facility. IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

XI. Instructional Planning and Scheduling**Professional Development**

This section provides information on the number of days provided for professional development and continuous professional growth in the most recent three year period. Questions that may be answered include:

- What are the primary/major areas of focus for staff development and specifically how were they selected? For example, were student achievement data used to determine the need for professional development in reading instruction?
- What are the methods by which professional development is delivered (e.g., after school workshops, conference attendance, individual mentoring, etc.)?
- How are teachers supported during implementation (e.g., through in-class coaching, teacher-principal meetings, student performance data reporting, etc.)?

At Tustin Ranch Elementary we have on-going professional development throughout the year. The focus of our professional development is the literacy strategies from the book, *Strategies That Work*, by Stephanie Harvey and Anne Goudvis. Based on the results of our California State Assessment and our district benchmarks, the school's leadership team decided to focus on best practices in reading instruction to increase reading comprehension in all grade levels. The strategies are taught in our professional development meetings by our teaching mentor and teachers. In addition, over 75% of our teachers are trained in the district's GATE program, and over 70% of our teachers are trained in Systematic ELD. The teachers are supported and coached by the Cotsen Mentor Teacher on Special Assignment and the Principal. The teachers of Tustin Ranch Elementary School are members of grade level Professional Learning Communities who work together to ensure that our school mission of "academic success for all" is achieved.
