Obligations

ALL obligations must be cleared in order to pick up your cap and gown for graduation, participate in events and receive your diploma. Graduation tickets and your diploma will be held until all obligations are taken care of. **Checks will no longer be accepted in the student store after April 9th (cash or card only).** Seniors should be aware of any obligations that are still owed and take care of this **immediately**. Obligations are posted on the Senior Schoology page (join code: D7ST-P7C8-V2KB7) by short ID number starting April 1 and updated every Thursday until May 20th. ON SALE: 5/03 – 5/18

Your last two senior events (Aloha Picnic and Prom) will be ON SALE from **Monday 5/03 through Tuesday 5/18 ONLY**. Please purchase your tickets at the student store. The student store is open daily from 7:30am - 3:00pm (closed 11am - 12pm for lunch). The student store is unable to accept checks – **CASH or CARD ONLY** for the remainder of the year. The senior picnic is on 5/21 from 9am - 1pm and is \$20 per student with ASB, \$25 per student w/out ASB. This price includes donuts, juice, a bbq lunch from Blake's Place and the Kona Ice Truck for a sweet treat! Prom is on 5/21 from 8pm - 11pm at FHS. Tickets are being sold in the student store for \$45 w/ASB, \$55 w/out ASB from 5/03 - 5/07. Ticket prices increase to \$55 w/ASB, \$65 w/out ASB from 5/10 - 5/18. Ticket prices for prom are per student. You may bring one guest to prom as long as your guest fills out and returns a signed permission slip AND COVID Consent Form. Permission slips AND COVID Consent Forms are available in the front office, at the student store, on the Senior Schoology page and the FHS website under Activities- Seniors. The guest price for Prom for non-FHS students is \$75.

Senior graduation caps, gowns, and tassels will be handed out on Wednesday 5/12 in the FHS quad. **Seniors will not be able to pick up their cap & gown until all obligations have been cleared.** If a senior is unable to pick up his/her/their cap and gown on 5/12, please see Mrs. Ginter in the student store before 3pm on 5/21. Caps and gowns are required to participate in graduation and will not be distributed after 3pm on Friday 5/21. If you did not purchase a cap and gown, you may do so for \$40 (cash only) on May 12 during cap and gown distribution. Also, you will be expected to pay for any repairs that your laptop may need (cracked screens, etc...). Any repair costs needed will be included in your obligations.

Seniors taking AP exams may keep their device until after AP testing is complete. Seniors will not be able to pick up their diploma until their device has been returned.

Welcome to your Senior Picnic and Yearbook Signing Party! Come hungry because you'll be enjoying donuts and juice for breakfast, a BBQ feast that will be catered from Blake's Place for lunch, followed by dessert from Kona Ice ☺ This event will take place on FHS's campus (location will be shared at a later date). You will need to check in to receive your wristband (which you need in order to get your food). The theme for this year's picnic is Hawaiian Luau, so bring your leis! Students will be receiving their yearbooks during this event. **Students who did not pre-order a yearbook will be able to purchase one at the student store on the day of this event. Seniors will be having Prom! Enjoy one of your last events at Foothill with a real (non virtual) prom experience! Seniors check in on campus at the junior gate to enjoy some fun activities planned by ASB and the Junior Class. Prom is on 5/21 from 8pm - 11pm at FHS. **Tickets are being sold in the student store for \$45 w/ASB, \$55 w/out ASB from 5/03 - 5/07. Ticket prices increase to \$55 w/ASB, \$65 w/out ASB from 5/10 - 5/18.** Ticket prices for prom are per student. You can pay using a credit card or cash only.

- You are not allowed to attend this event if you did not purchase a ticket in advance. No tickets will be sold the day of the event.
- You must turn in a permission slip **and** COVID consent form when you purchase a ticket to this event.
- Prom is a semi-formal event. Long dresses, heels, suit jackets, and tuxedo's not required.
- Non-FHS guests are permitted. Guests must fill out and sign a permission slip **and** COVID Consent form. The completed permission slip, along with a copy of the guest's ID is needed when purchasing a ticket for a guest. ONE guest per FHS student. A guest ticket costs \$75.
- **Please make sure to take care of your obligations before this event, in order to participate.**

Graduation: Monday, 5/24/21 @ 8:00am, 11:00am, & 2:00pm

Commencement will be held at 8:00am, 11:00am, and 2:00pm at Northrup Stadium on Monday, May 24th. The sign-up form will be released on April 28 @ 10:00am on the Senior Schoology page (join code: D7ST-P7C8-V2KB7). Graduates are to arrive 40 mins prior to the ceremony, and need to carry their cap and gown in. You will put on your cap and gown once inside the Tustin gym (girls may want to bring hair pins to secure their caps).

- **Parking:** Based on your seating location, you will park in the THS parking lot (GOLD home side) or off of San Juan Street (BLACK visitor side). Graduates **must arrive** promptly, 40 mins prior to the start of the ceremony. Parking at graduation is first come, first served. **Do not be late.**
- **Graduation Streaming:** This year the graduation ceremony will be live-streamed; the link will be found on the Foothill High School website on the Home Page (www.tustin.k12.ca.us/foothill) as well as in the Senior section under activities.
- **A professional photographer** from South Coast Photographic will photograph each student after his/her/their name is read. Please allow 72 hours for the images to go online for viewing and ordering. To view and order go to: www.southcoastphotographic.com, click on commencement ceremony photo, then click on search for photos, and search by student permanent ID number. To receive \$5.00 off orders of \$25.00 or more please enter code FOOT21. The coupon will only be good on orders received before July 31, 2021. Ordering your commencement photograph is available up to 90 days after the graduation date.
- **Diplomas** will be distributed on starting Tuesday, May 25th from 8:00am – 4:00pm. Seniors are expected to pick up diplomas from the front office entrance. If you have borrowed your cap and gown, you **MUST return the cap, gown, and tassel in order to pick up your diploma.** If you have obligations, athletic equipment to return, or laptops to return after AP testing, you **MUST return the items** in order to pick up your diploma.

It is our expectation that each student will be properly attired for the ceremonies.

If not, the student will not be allowed to participate.

Graduates will not deface their caps and gowns in any manner nor will they be allowed to wear anything around their neck other than school issued items (no leis). It is expected that students will be appropriately attired for this formal occasion.

- **Suggestions:** dress slacks, dress shirts, ties, and dress shoes (nice Vans do not qualify as dress shoes); dresses, blouses, appropriate shoes. Any type of pointy/spiked heels will not be allowed due to the turf on the field at Northrop Stadium. You may only wear flats or wedge-style shoes - **BEWARE: many girls have trouble walking on the turf with wedges and have fallen.**
- **The following is considered inappropriate attire:** jeans, shorts, cut-off pants, baggy pants, mini-skirts, tube tops, midriff tops, tank tops, T-shirts, “beachy” flip-flops, spiked heels or tennis shoes.

The Tustin Unified School District graduation requirements include a citizenship requirement stating that a student must have maintained acceptable standards of citizenship during the period of high school enrollment up to, and including, the final Commencement Ceremony. It is our hope that no student will display disruptive behavior before or during the ceremonies. Any student under the influence of alcohol, or any other controlled substance, will not be allowed to participate in the ceremonies. A breathalyzer will be available for administrators to utilize. If an administrator has a reasonable suspicion that a student is under the influence of any type of intoxicant, the student will be tested using the breathalyzer. Inappropriate behavior is subject to withholding of the TUSD Diploma and possible removal of the student during any ceremony.

GRADUATION DETAILS

CAP & GOWN DISTRIBUTION

Seniors will be able to pick up their purchased or borrowed caps and gowns at the cap and gown distribution event on **Wednesday, May 12, in the quad. Last name A-F @10am, G-O @11am and P-Z @12pm.** If you are unable to come during this time, please pick up your cap and gown from the student store before Friday, May 21, at 3pm. The student store is open daily from 7:30am - 3:00pm (closed for lunch 11am -12pm). Students who did not pre-purchase a cap and gown package may purchase a cap and gown at the distribution on May 12 for \$40 (cash only).

What If I am using my sibling's gown? If you will be using a black gown worn from a previous Foothill High graduate, you must still purchase a cap, tassel and medallion to complete your ensemble. They are \$10 each, **cash only**, and may be purchased at the Josten's table at the cap and gown distribution on May 12.

COMMENCEMENT DETAILS

Due to COVID protocols, Foothill High School is planning three smaller, IN PERSON commencement ceremonies at 8:00am, 11:00am, and 2:00pm at Northrup Stadium on Monday, May 24th.

Graduation Will Feel Different,

Graduation will look and feel very different than it has in the past. The format we will use this year will not require a rehearsal and will allow us to try some new things that we have never done at FHS. Students will be able to choose the ceremony time, and sit alongside their friends instead of in the traditional alphabetical order. Graduates and their guests will check in at the same time, 40 minutes prior to their selected ceremony.

Graduation Ceremony Reservations

Graduates are limited to 3 guests and will only be allowed to make a reservation for **ONE** ceremony. **The FHS Graduation Ceremony selection form link will open LIVE on the Senior Schoology page on Wednesday, April 28, at 10:00am and will close on Sunday, May 2.** Please plan ahead as to which ceremony the graduate and guests will be attending. Make sure guests will be able to attend the chosen time prior to submitting your response. **Requests are time stamped and will be filled on a first come, first served basis.** Please keep in mind your preferred time may fill up, so you will be required to select a 2nd and 3rd choice. Once the 200 student spots have been filled in each time slot that ceremony time will close. A receipt response will be emailed to the student's email after the form is completed. **You will receive confirmation of your ceremony time the week of May 3 via the graduate's @mytusd.org email address.** All graduates must submit the selection form to participate in the ceremony.

A reminder notice will be sent before the link opens and will be sent directly to the graduate's @mytusd email address. The ceremony selection form will be limited to 1 response to prevent multiple entries. At the time the graduate completes the form he/she/they will also be selecting a preferred side of the stadium for seating. The GOLD side (home bleachers) backs up to the THS campus. The BLACK side (visitor bleachers) backs up to San Juan Street. Family members will want to sit on the same side in the stadium as their graduate. **Requests are time stamped and will be filled on a first come, first served basis.** The graduate will be informed of their side later in May.

Remember: coordinate with your friends and family in advance before selecting your graduation time and field side. If you do not sign up for a ceremony, we will assume you do NOT wish to take part in commencement.

Please see the attached map of the stadium before selecting your preferred seating arrangement.

Graduation Entrance

Due to the social distancing guidelines in place at the moment, a maximum of three guests will be allowed to enter the stadium with each graduate. Graduates and their three guests must check in at the same time, 40 minutes prior to their selected ceremony.

You must enter as a group, so please connect with your family members before arriving at the gate. No one will be allowed to enter without a graduate. Three tickets will be given to each graduate, but they will not be collected when you enter. Neither graduates nor family will be allowed to leave and re-enter for any reason, so have everything you need before you enter.

There is handicapped seating on both sides of the stadium. Sections of bleachers will be on the track or have a ramp for family members who have difficulty with stairs. No special pass is needed. Please have one family member sit with your handicapped person and the rest of the family sit in the regular bleachers.

Babies who are held may be carried in, but toddlers who can stand and walk are considered one of your three guests. Strollers are not allowed inside the stadium.

If you lose a tassel or medallion at the last minute, take **cash only** to Mrs. Deehan at the graduation check-in location, on May 24, for a replacement (THS Sports Pavilion). Replacement items are \$10 each.

Parking and Seating

Parking on the same side of the stadium that your graduate is sitting on will be the most convenient for you. Since parking is limited, it is recommended that the graduate and guests arrive in the same vehicle.

Black Side Seating - Attendees and graduates who will be sitting on the BLACK side (visitor bleachers) will park on the field behind the visitor bleachers off San Juan Street. Black side attendees and graduates must check in at the THS Sports Pavillion. Once the ceremony is over, the graduates on the Black side will be exiting the field area behind the visitor bleachers to meet up with their guests/family members. (Please see the attached map for reference)

Gold Side Seating- Attendees and graduates who will be sitting on the GOLD side (home bleachers) will park in the main parking lot at Tustin High. Please be aware that this lot may fill up. Gold side attendees and graduates must check in at the THS Sports Pavillion. Once the ceremony is over, graduates on the Gold side will exit out to the parking lot to meet up with their guests/family members. (Please see the attached map for reference)

There are a limited number of handicapped parking spots in the high school parking lot. Vehicles with a **legal** handicapped placard will be allowed to park there.

Ceremony to be Livestreamed

The plan is to livestream graduation. Barring any technical issues, graduation WILL BE livestreamed. Details will be shared at a later date.

Dress Code for Graduation Ceremonies

It is our expectation that each student will be properly dressed at the Graduation Ceremony. Students who are not dressed in appropriate attire may be removed from the lineup. Nothing may be put onto graduation caps except the Foothill tassel. No adornments are allowed around the graduate's necks except the school ribbon and medallion or Honors cords or sashes. The seniors will look professional and coordinated in their dress clothes and black and gold graduation attire. Please have your guests hold any other adornments until after the ceremony.

Appropriate Dress Code:

Cap and gown

Dress slacks, dress shirt (tie optional), blouses, skirt/dress

Dress shoes - FLATS OR LOW WEDGES ONLY. No tennis shoes.

Since you will be walking on the football field, high/spiked heels are unsafe and detrimental to the turf. You will not be allowed onto the field unless you are in flat heels.

Graduates may not bring backpacks, bags, purses or food/drink in with them. Please have your guests hold any personal items for you until after the ceremony.

Fireworks

Noise Makers

Balloons

Signs

Umbrellas

Please respect the dignity of the ceremony and adhere to these guidelines.

Behavior: Students are expected to behave in a mature and dignified manner before, during and after the ceremony. All senior activities and ceremonies are school functions; all school rules apply and will be enforced. Inappropriate behavior will result in removal from the ceremony.

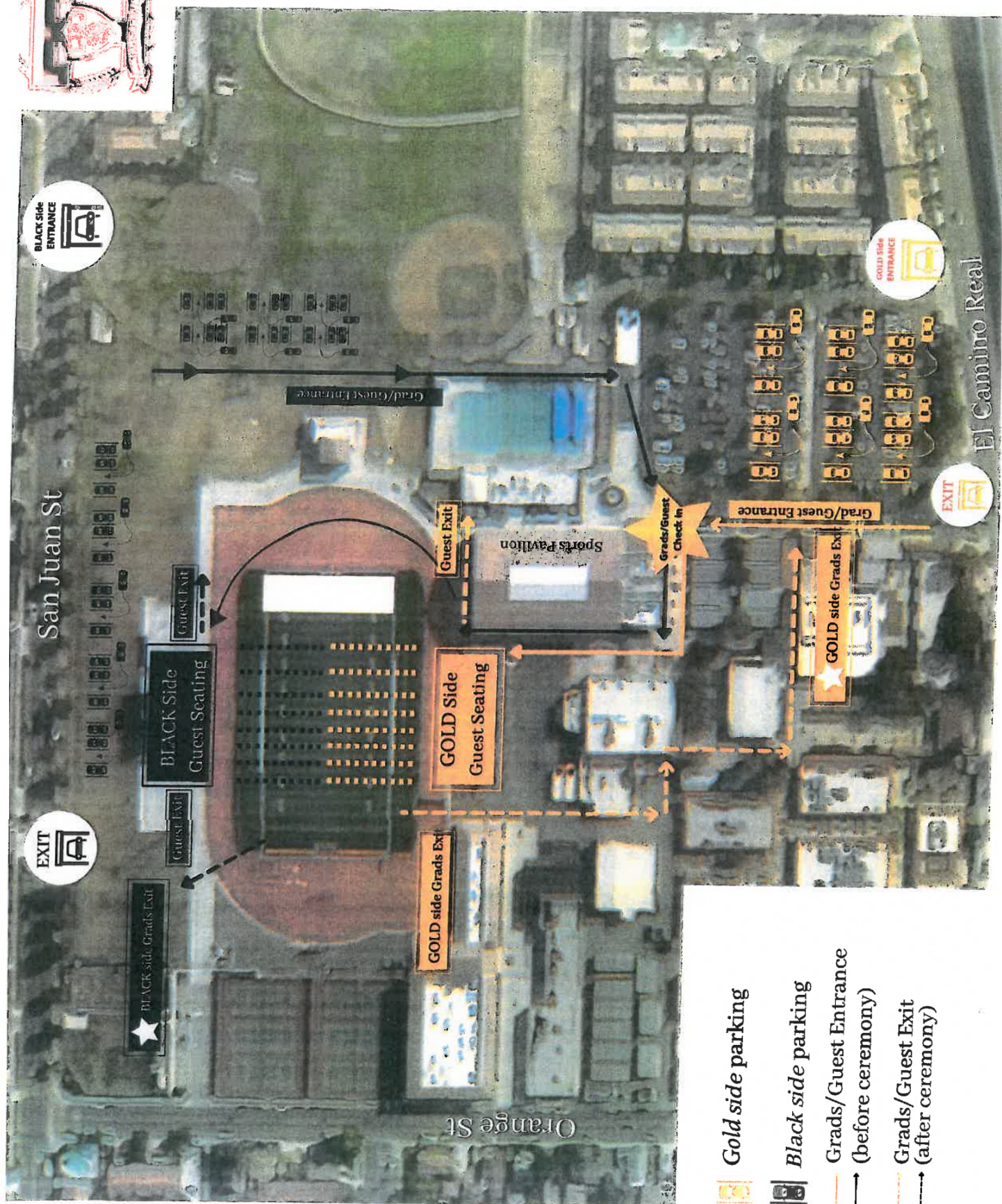

Prom Rules

All Foothill students must comply with the school/district rules as well as the listed additional rules. All attendees must present current school identification to be admitted. Prom is a semi-formal event. All school rules and regulations apply to all in attendance. Students have the option to leave the event early at any time and FHS supervision is not responsible for them after they leave the event. The following items are not permitted into the event and will be confiscated: gum, food, or beverages. The school is not responsible for lost or stolen items. Students who leave the event for any reason will not be readmitted. **NO limousines, party buses, sprinter vans, and/or vehicles that hold more than the standard 8 passengers will be allowed.** NO PURCHASING OF TICKETS AT DOOR.

This is a high school event. Possession and/or use of tobacco, alcohol and controlled substances are prohibited. Any student (or guest) arriving at the event under the influence of (or in possession of) an illegal substance will not be admitted.
