District K-8 textbooks in the subjects of English language arts, mathematics, history/social science, health, foreign language, visual and performing arts, and science have been adopted from those approved by the State Board of Education. The Tustin Unified School District Board of Education has adopted district textbooks in the subjects listed below. K-12 textbooks for mathematics, history/social science, science, English language arts (including reading), and foreign language are aligned with state-adopted content standards and state or national frameworks. All TUSD students, including all English learners, have textbooks* and instructional materials, including science laboratory equipment at the 9-12 level, that are current and in good condition in accordance with Education Code requirements. All textbooks* and instructional materials are provided in sufficient quantities for each student for use in class and to access from home.

On September 27, 2021, the Tustin Unified School District Board of Education verified by resolution that each student at this school has a textbook and/or instructional materials for each core subject area that are aligned to the content and cycles of the curriculum framework adopted by the State of California.

School Facility Conditions and Planned Improvements

The Tustin Unified School District takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses a facility survey instrument developed by the State of California Office of Public School Construction (OPSC). The results of this survey are available at the school office, the District office, or on the Internet at <https://tinyurl.com/TUSD-Facility-Inspection-Tool>. The District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Beswick had extensive upgrading completed in 2003-2004. Restroom facilities and all classrooms were made ADA compliant as were bus and car access areas. The administration building and multi-purpose room were both re-roofed and exterior lighting was enhanced. During the summer of 2013, the entire school exterior was painted. In the summer of 2016, Beswick's MPR was upgraded with new technology and sound equipment. The summer of 2020, each classroom's technology was upgraded to include new projectors in each classroom. A solar structure was installed in 2020.

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.

Our School Safety Plan includes the following elements: Child abuse reporting procedures, disaster procedures, attestation plan for COVID-19, routine and emergency; suspension, expulsion, or mandatory expulsion recommendations; procedures to notify teachers of dangerous pupils; discrimination/harassment policy; provisions of any school-wide dress code; procedures for safe ingress and egress; safe and orderly environment; rules and procedures on school discipline and dress code; hate crime reporting; school safety goals and objectives. We run monthly drills and work closely with our Student Services department to ensure that we have updated procedures and practices in place to ensure school-wide safety.

Student safety is of utmost importance at Beswick Elementary School. A comprehensive safety plan is part of our overall School Improvement Plan and is revised and assessed annually. Students and staff participate in both emergency drills and fire drills. Prior to these drills, students are taught the appropriate safety practices and staff members are trained on their specific area of support. After each drill, the staff reviews the effectiveness of our procedures and makes any necessary revisions. Emergency preparedness supplies and equipment are inventoried on an annual basis to ensure that the needs of our students will be met in the event of a disaster. A Crisis Response Team has been initiated at our site as well as a redesigned communication corridor to improve the speed and accuracy of communication in the event of a disaster.

2020-21 Types of Services Funded

Beswick Elementary School receives funding for categorical programs focused on ELL and At-risk students that are available at our school site in addition to base funding to support all students. These program funds include LCFF-EL and Schoolwide Title I Program funds. The Tustin Public Schools Foundation and site PTO/PTA also supports the school with donations and financial support throughout the year to support school-wide programs and events for students. The school's Single Plan for Student Achievement (SPSA) identifies student needs and addresses specifically how these categorical funds will support student learning and achievement through a Multi-Tiered System of Supports. The categorical funds are used to provide tiered and targeted supports or interventions for at-risk students in the areas of academics, behavior and social emotional learning, and absenteeism, professional development, instructional materials, additional personnel to support all students in accessing academic standards, and technology resources.

Beswick Elementary School receives funding from the following state and federal categorical funds for programs and services: Title I (support personnel, para educators, substitutes for teacher release days, technology, intervention program materials, professional development, parent involvement, data analysis, books to expand library selection, supplemental materials for at-risk students and program acceleration), and LCFF- ELL Local Control Funding Formula for English Language Learners (para educators, ELD program, technology, supplemental materials for English learners).

Professional Development

Tustin Unified School District provides dedicated time for professional development for all staff. Schools often provide additional professional development time based on specific school-site scheduling and budgetary decisions. The District provides intensive workshops in August during the week before school starts to provide teachers with new knowledge and enhanced skills for the upcoming year. Staff development opportunities are also offered after school and by release time throughout the school year. New teachers are provided an extensive new teacher training program throughout the year to support their implementation of effective instruction.

In prior years Beswick Elementary has surveyed its teachers and reviewed the results of assessments to identify areas of need and schedules staff development to strengthen the educational program. We analyze data trends and teachers have PLC time available on Mondays and twice a month on Wednesdays. We also have monthly Banking Minutes Professional Development opportunities. During these times, teachers receive training in literacy, mathematics and English Language Development. The staff utilizes data analysis protocols to systematically evaluate the results of assessment and evaluate instruction and drive decision making. In addition to site based activities, teachers participate in a variety of District in-services as well as professional development workshops and conferences to enhance their knowledge and instructional skills, especially in the areas of Balanced Literacy and Conceptual Mathematics. Over the past three years, there have been summer institutes, summer training on campus around CGI and Balanced Literacy, and ongoing coaching and expert push-in coaching. Beginning teacher Induction Programs, District workshops, and professional conferences are also opportunities for professional development. The District continues to train teachers in strategies to deliver a differentiated curriculum with depth and complexity. Teachers utilize student assessment results to target instruction to better meet the individual needs of students. Our school wide focus is Reading/Phonics, SEL, Math/CGI and Balanced Literacy Practices.

Professional development this year has been heavily focused on social emotional learning for both teachers and students as well as on differentiation strategies to support student's learning needs. Looking at data in PLC and staff meetings we were able to determine the need for professional development needs in both social emotional learning and foundational reading instruction. Through the support of both our counselor and our intervention teachers on campus who provide in- class coaching and student differentiated support, teachers are able to build their teaching skills with a supportive team. Each month we are able to analyze data and adjust our support based on the needs of the students. Conference attendance is supported in areas that support our school focus areas.
