COC Minutes August 9, 2006

Discussion Item:

1. Phase II Status

Brock Wagner shared that the Phase II Measure G construction projects at Benson, Heideman, Tustin Memorial Academy, Columbus Tustin, Currie, and Utt schools are going well and are on-time. Also, the Phase I painting and roofing projects at Foothill and Tustin high schools and the slurry coating at eleven schools are complete.

Fausto Silva from Pinnacle One provided an overview of the Phase II Project Budget Report. The Committee discussed the report for clarification, format, and ease for public review. George Jeffries requested that the change order process be reviewed by staff for a simpler format. Lisa Frost also requested a summary of general information from the original scope of work and change orders, staff to comply.

2. Bond Issuance/FHS Master Plan

Brock Wagner shared that the process for the Series "B" Bond Issuance for \$17.3 million is completed and the funds will be used for Phase II construction projects. Also, on August 9, the Board approved the Foothill High School Master Plan, with NTD Stichler as the architect. NTD will begin the design phase for the infrastructure of a science building, with a design completion date of summer 2007. The District anticipates a 1 to 1-1/2 year timeline for Phase III infrastructure and construction phase. A summary plan will be presented at the next COC meeting.

3. Marine Corp Air Station (Tustin)

Brock Wagner shared that Lennar Homes is continuing to make progress on the MCAS. They are anticipating residential occupancy in January 2007 that will generate students for the District. The commercial construction phase is also progressing. The District continues negotiations with Legacy (Centex/Shea Homes) and we anticipate completion of an Agreement in the near future. Staff continues to move forward with the State, developers, etc., for a new high school on the Base.
