Types of Services Funded (Fiscal Year 2017-18)

Hicks Canyon Elementary School receives funding for categorical programs that are available at our school site through the Local Control Funding Formula. The school's School Plan for Student Achievement (SPSA) identifies student need and addresses specifically how this categorical fund will support student learning. Much of the 2017-18 fiscal funding was used for 21st century teaching and learning by having every grade level becoming a 1:1 iPad school. With so much technology, funding was also used to support software licenses and a highly qualified three day 21st century coach to support staff on the schools goals. In addition to the 21st century focus, HCE top priority was to ensure learning for ALL students. Funding was also used to hire extra support staff to oversee our intervention program for identified At-Risk and EL students. With 21st century teaching and learning at the forefront and intense interventions as the school's priorities, that is why HCE is recognized as a high academic achieving school.

Professional Development (Most Recent Three Years)

For the 2016-17, 2017-18 and 2018-19 school years, HCE dedicated teachers engage in collaborative planning two Wednesdays each month. The principal provides staff professional development meetings that focus on the processes of Balanced Literacy, English Language Development, Cognitively Guided Instruction in Math (CGI), differentiating instruction, data interpretation and analysis and best first 21st century instruction.

In 2015-16 and 2016-17, the primary focus with Cognitively Guided Instruction in Math where we consulted with OCDE to have Nick Johnson, a doctoral expert from the UCLA math lab project, work with our teachers. Last year teachers also had an opportunity to attend CGI workshops through OCDE and eight staff members attended the CGI National Conference in Seattle to learn CGI best practices. These opportunities have helped to keep HCE teachers grow in best math practices.

This 2017-18 and 2018-19 school year our site chose to focus on Balanced Literacy, specifically Writing Workshop. We have contracted with Momentum consultants to provide professional development in the area of Writing Workshop. We continue to meet in weekly Professional Learning Communities (PLC) to plan and target instructional practices. The school leadership team meets to discuss school-wide timelines, data, and systems to support student learning. Teachers are also supported by the 21st century instructional coach. The coach plans and works with teachers to improve instruction in Writing Workshop and English Language Development integrated with technology practices to ensure success for all students. We look forward to refining our literacy instruction with our high quality professional development opportunities.
